2017 Annual Meeting June 10

Proposed Amendments to the Bylaws of the Historical Society of Washington County, VA, dated May 6, 2008:

AMENDMENT 1

Section 3.3 ATTENDANCE: If a Director or Officer fails to attend three consecutive meetings per year [including participation in E-Mail meetings], that Director or Officer will be deemed to have resigned and his or her position shall be deemed to have become vacant for the remainder of his or her term or until the vacancy is filled pursuant to Section 3.5 of these bylaws. A majority of members of the board may waive this requirement in rare extenuating circumstances.

Purpose: Removes the undefined time period 'year'; adds E-meetings; provides for an appeal

AMENDMENT 2

Section 4.3.1 PRESIDENT:... The President shall, with the approval of the Board of Directors, appoint the chair and the members of all committees except the Nominating Committee ... {re: Section 5.6 Nominating Committee}

Purpose: Removes the appointment of Committee members as a responsibility of President; removes a conflict with Section 5.3 Committee Chairs

AMENDMENT 3

Section 5.5 EXECUTIVE COMMITTEE: Eliminate this section entirely, including these sub-sections referenced here: Sec 5.5.1 Composition of the Committee; Section 5.5.2 Powers and Functions; and Sec. 5.5.3 Reports to Board.

Purpose of Amendment: Committee's primary purpose was to act on matters requiring immediate attention; E-mail communications and meetings have eliminated need for this committee

AMENDMENT 4

Section 5.7 FINANCIAL REVIEW AUDIT—COMMITTEE: The President shall, with the approval of the Board of Directors, designate, within 60 days after the end of the fiscal year an a Financial Review Audit—Committee composed of not less than three (3) Society members who are not members of the Finance and Management Committee and which committee shall:

Section 5.7.1 Perform the <u>review</u> <u>audit-or</u> recommend an independent auditor. If an independent auditor is selected, with the approval of the Board of Directors, the Financial Review <u>Audit-Committee</u> . . .

Purpose of Amendment: Changes the designation from Audit to Financial Review, more accurately describing the level of examination performed

JOHN W. GARDNER POTTERY

J. W. Gardner, Sr. was born in Virginia on February 6, 1837. He first settled in Washington County about 1867, on a tract referred to as the Bowman lands bounded by properties owned by Ingles, Pippins, and Talberts, which included a strip across Raccoon Valley. Later he owned a section on the North Fork of the Holston River that contained the former Bowman Mill, later referred to as Gardner's Mill.

By 1870 he was working along the North Fork across the River Ridge from the community of Craig's Mill, which was located at the Jasper Creek - Smith Creek intersection. He brought his wares across the Ridge in wagons or on horseback using a trail known as "the Winding Stair", and he found a ready market in Craig's Mill. He also took his wares to nearby Mendota and to the distant towns of Abingdon and Bristol Virginia/Tennessee.

It is reported that he owned 4 kiln sites in the area along the North Fork and his son John, Jr. helped him operate his pottery business. J. W. Gardner, Jr. was born about 1864. He likely began helping his father when he was a teenager. It is not known for sure when the operation ended, but the lands were sold around 1910.

Gardner, Sr. died in March 1907 and is buried on the north side of the North Fork in a family cemetery not far from the Mendota Rd.

The crock (pictured r) owned by the Historical Society is approximately one gallon capacity and is stamped: *J.W. Gardner & Co/Craigs Mills, Va*, in an oval. Below that is the number 1 in a stippled circle.



E. W. MORT - POTTER of ALUM WELLS

Edward William Mort was born in VA about 1853. In 1880 he is boarding with Dr. William Lancaster in the Kinderhook District of Washington County. He is possibly working in the Wooten Pottery shop learning the craft, or he may well have already learned it, or became attracted to making it a profession, since he was born in the pottery hotbed of Strasburg, VA. One source states he had his own shop by 1881.

Alum Wells is located on Rt. 802 (Mendota Rd), midway between Holston and Mendota communities, and before reaching Zenobia and Wooten Gap, the area the Wooten's potted in. Assorted shards of Mort pottery were reported in the Gardner kiln wastes, so he may have also worked with Gardner. Like Gardner he would have transported his wares to Craig's Mill, Abingdon, Mendota, & Bristol.

In 1888 he was potting in Chilhowie in Smyth County, Va. per a newspaper ad noting he was selling "jars, jugs, churns, crocks, fruit jars, and everything else in the stoneware line. E. W Mort - Manufacturer."


In 1893 Mort became a minister of the Holston Conference at Emory Va. He died in 1923 and is buried in the Emory cemetery.

I have seen more of his pottery, mostly crocks and canning jars, than that of the other potters of Washington County. Mort marked the majority of his wares with a stamp - *E W Mort/Alum Wells, Va.* But unsigned pieces have been attributed to him.

A Monumental Discovery

In May of 2014, a town employee contacted Charlie Barnette and Carol Taylor about a monument that had been discovered by workers clearing a lot on Russell Road. Upon exploring the site, a monument for James L. Brown

was found in sections that were scattered down the steep hillside. Several large bones were also found. Research indicated that this was the site of Brown's marble works. After it was determined that this was the burial site of James L. Brown, the town reset the monument and cleaned the hillside. As far as can be determined, Brown's is the only grave on the site.

James Leftwich Brown was born May 1829 to Nimrod and Sarah Lucas Brown in Giles County, Virginia. He and Clementine Ellen Hale were married in 1854 in Giles County, and began their family there with the birth of daughter Sarah, their oldest child. Clementine would have eight more children, two of which did not survive into adulthood (see below).



James enlisted in the Confederate Army, Company H, 36th Virginia Infantry Regiment on 18 Apr 1862 in Giles County. The family remained in Giles during the war and two of the children were born in 1863 and 1866.

At some point after the 1870 Census the family moved to Mercer County, West Virginia, where the youngest child, Chapman Johnston, was born October 1877. The 1880 US Census shows James and Clementine living in Mercer County, along with all seven of their children including their married daughter, Sarah Woolwine. The family's time in WV did not last long, however.

By 1881 James, Clementine, and their children had arrived in Abingdon. In April 1881, Brown bought a house



from G. M. Snodgrass located on the corner of Russell Road and Wiley Street. Snodgrass was part of a firm contracted to transport the U.S. mail and Brown contracted to deliver the mail in return for purchasing the house. which still stands today.

By 1888, Brown had established a marble works just up the street from his house and near Sinking Spring Cemetery. His business, Abingdon Marble Yard, dealt in American and Italian marble, monuments, and tombstones. Later, in addition to his marble works, he was providing steel fences for the residents of the town. In the 1900 Census he and sons Robert and Chapman listed themselves as "Marble Dealers". In the same Census another son living in Russell County was listed as a "Manufacturer Tombstones".

James L. Brown died in 1909. His sons Robert and Chapman continued to operate the marble works. Clementine died in 1917. In the 1920 Census, the two men, who never married, were still in the same house; Robert was "Proprietor" of a marble yard and Chapman was a "farmer". Robert died in 1922, at age 54.

Chapman continued to own and work in the marble yard, but in the 1940 Census he also indicated "income from another source". Chapman Johnston Brown died in Abinadon in 1952.

Now for the rest of the story: As each family member passed away, they were returned to Giles County, VA for burial, including, apparently, James L. Brown,

who has a grave stone in Staffordsville Cemetery,

Giles County, VA.

So, where is his final resting place after all?
